## APRIL UPDATES FROM THE LAND USE COMMITTEE

The ESIA Land Use Committee considered four proposals this last month referred to us by the City:

- Sutter Park setback deviations: No opposition. We contacted one of the neighbors who confirmed they did not have concerns.
- 5841 Newman Court Local 447 expansion of assembly space: No opposition.
- 3003 O Street rehab of historic building and conversion to day care center: No opposition.
- 3002 O Street conversion to six dwelling units: No opposition.

ESIA continues to monitor the proposed Streamlining the Planning Entitlement Process ordinance. This item was rescheduled at the Planning and Design Commission (PDC) for Thursday, April 23. ESIA previously sent a letter of support to the PDC. Some groups have expressed concern about the ordinance and the PDC will be considering those comments.
